Minutes of the Meeting

The fourth meeting of the Baa Atoll Conservation Fund Board was attended by 9 participants from 7 stakeholder organisations (Annex 1).

The meeting was chaired by the Director General of the Ministry of Environment and Energy, Mr. Ibrahim Naeem.

In his opening remarks he welcomed all members who attended the meeting and briefed the participants on the agenda (Annex 2) scheduled for the meeting and also informed that this is the first meeting of the Board which is being held outside Male'.

He also highlighted that the main agenda items for discussion for the day includes approval of BACF Budget and the Approval of Grants from BACF.

Agenda, Item 2

Presentation of BR Office Workplan 2014

As the BACF budget was presented in the third meeting held on 14 August 2014, the Chair highlighted that the participants present at the third meeting requested the need for all documents to be received before hand so that the participants would have enough time to go through the relevant documents and in this regard all documents were forwarded to all after the meeting.

BACF Manager then presented the revised BACF budget for 2014 (Annex 3) with the feedback received from the third meeting held in Male'.

With regards to BACF 2014 budget the following were discussed:

RESORTS

- Resorts are ready to assist the BR Office and its management.
- Profit and loss statement for each year with details are required when discussing the budget.
- Budget should be approved at the start of the year not midway through the year.
- 3 resorts have signed the partnership agreement, only 1 is paying, therefore BACF need to sit down with the signed parties to bring them onboard.
- Discussions need to be undertaken with Dusit and the to be opened Amillafushi Resort as well on the issue of signing partnership agreements.

- Would abstain when asked for a vote on BACF Budget, main reason being level of discomfort amongst the resorts.

LGA

- Right time to address why the partners are not contributing as things seem to be on the right track in the field.
- Not happy with the level of contributions received.

ATOLL COUNCIL

- Island communities are eagerly waiting to see results of BACF in terms of grants.
- The BR Office has been very active, so the future looks bright as Rangers are present and the Office is functioning well.

LAM

- Liveaboard budget varies from Operator to Operator.
- Need time to discuss issues amongst themselves if there are any issues that require the general consensus of the Liveaboard Association.
- Ready to contribute and support the Biosphere Reserve.
- Dharavandhoo reclamation had a big effect on arrivals from Liveaboards to Hanifaru in 2013.

BACF

- In order for the smooth running of all operations there is a strong need for all parties involved to sit together more frequently and the monthly meetings which are taking place is a good start.
- There are a lot of new faces around the table, they also need to be made aware and updated on what has happened and is happening at present and of future plans.
- Working together only we can solve the issues that we are facing.
- There has been a remarkable improvement in the management of the Biosphere Reserve in 2014.
- Apart from the government contribution in the management of the Biosphere Reserve the Atoll Council is also contributing in-kind through the arrangement made in terms of Office space for the BR Office.

CHAIR/EPA

- The Chair agreed that there are issues with communication and this needs to be addressed.
- Meetings have been infrequent due to the change of Board members and difficulty in getting names to the Board.
- The budget meeting would have taken place prior to this meeting if this was in order.
- Details required from BACF by the resorts are sometimes unclear.
- The Government is keeping up its word in terms of its annual contribution and the other budget support to BACF, BR Office and the management of the Biosphere Reserve Office.
- The funds received by BACF are accounted for by the Finance Department of the Ministry of Environment and Energy.

The following decisions were taken by the BACF Board in relation to Budget.

- a. BACF Board agreed that the budget to be approved by BACF Board before commencement of each calendar year rather than midway through the year.
- b. The Board also agreed to discuss the BACF budget for 2015 before the end of 2014 and to approve it before the start of 2015 and advised to make all necessary arrangements for this to happen and the required paper work to be completed on time and to be tabled to BACF Board for approval.
- c. The Board members voted in favour of passing the BACF budget except for the representative from the Resorts who abstained from voting.

**3. Agenda, Item 2
Approval of BACF Grants**

BACF Manager Mr. Abdulla Shibau gave an outline of the process undertaken in short listing the proposals and the evaluation process as well. He informed the Board that a total of 26 proposals were received by BACF upon its Invitation for Call for proposals (Annex 4). Also he stated that a 4 member Evaluation Committee was setup based on the recommendation by the second meeting of the BACF Board and the evaluation process was undertaken by the Committee. The Evaluators individually evaluated the proposals and after this process was completed all 4 Evaluators sat together to discuss all the proposals and to undertake the short listing process. A total of 3 projects were not evaluated in detail as these were not in line with the BACF call for proposal. (Evaluation Report, Annex 7)

With regards to BACF grants the following were discussed:

RESORTS

- Manta trust applied for grants from BACF on their behalf not on Four Seasons behalf.
- If resorts are receiving grants from BACF this will not send the right message to the communities for now.

LAM

- The proposal from Manta Trust does not fit in the criteria as a direct beneficiary of grants from BACF.
- The proposal from Manta Trust to be removed from the list.
- Remove the shortlisted proposal from Sonevafushi as well.

LGA

- If grants are provided to the resorts during the first phase of grants it will not reflect good on BACF.

RESORTS

- The argument is that most of the funds to BACF would be generated through the payments received by the resorts as Annual contributions; hence the window should be open for the resorts to apply.

ATOLL COUNCIL

- First the local communities must see and feel the results of BACF grants.

LGA

- Provided resorts are contributing the window should be open for the resorts to apply.

CHAIR/EPA

- In this cycle of grants no project to be awarded to a resort.
- The window should be open but a decision whether to award grants in future should depend upon the contributions received from the resorts.
- Should not change the grantee amount spelled out in the Call for Proposal even if there is a request.

LAM

- Since 2 proposals have been omitted from the list to include two proposals from the standby list.

RESORTS

- Need to improve the proposal from FEYLI of Eydhafushi on Engine Repair and Maintenance.
- The Certification at the end should be should be accredited and the Trainers should be certified.

LAM

- Can EPA be involved in any of these projects or act as a beneficiary?

RESORTS

- The Sponsor cannot be a beneficiary and the same rule must apply.
- Four Seasons currently conduct Engine Repair Courses and can act a mentor for the Engine Repair activity.

After discussing in detail the proposals received the Board advised the total number of grants for this cycle would be 7 instead of 9 as recommended by the Evaluation Committee.

The Engine Repair and Maintenance proposal by FEYLI of Eydhafushi should be improved as this proposal is unique compared to the other proposals. In this regard it was agreed that BACF should communicate to FEYLI to undertake the improvement and if possible by the end of the activities mentioned in the proposals the training given to be accredited.

The following decisions were taken by the BACF Board in relation to BACF grants.

To award grants for the following 7 proposals:

1. Introduction and Training Program on Hydroponics by Dharavandhoo Development Cooperative Society (Livelihood, Education/Awareness).
2. Training Course on Outboard Engine Repair and Maintenance by FEYLI of Eydhafushi (Livelihood).
3. Save Turtle Forum by Kendhoo School (Education /Awareness, Conservation).
4. Kihaadhoo Goes Organic by FAAM Foundation of Kihaadhoo (Education/Awareness, Livelihood).
5. Erection of Monument by Kudarikilu Council (Livelihood).
6. Eco friendly fertilizer production by Maalhos Women's Development Committee (Livelihood).
7. Training Course on Lacquer Works by Thulhaadhoo Council (Livelihood).

and

- a. No funding for projects to be awarded to any resort during this cycle from BACF.
- b. Communicate to FEYLI of Eydhafushi on the improvements required for their proposal.
- c. Communicate to all Grantees on their selection.

The 4th meeting of the Baa Atoll Conservation Fund Board came to a close at 1.00pm.

Evaluation Process

The 26 proposals received were initially checked by BACF to see whether they were in line with BACF Invitation for Call for pre-proposals and also in line BACF priority spending areas spelled out in the Invitation. It was found out that 3 proposals were not in line with the BACF priority spending areas and therefore these were not evaluated any further but these were shared with the Evaluation Committee members.

The 4 member Evaluation Committee evaluated the proposals as per the Concept Note Evaluation Form for Evaluation provided to the Committee by BACF. The 4 members of the Evaluation Committee initially evaluated the proposals individually and the members ranked the proposals based upon the Evaluation Form and on the Invitation for Call for pre-proposal document.

It was also decided by the members that after completing the Evaluation the Committee members would sit together to discuss the proposals together in order to make a decision on short listing.

Upon completion of Evaluation of the proposals individually the 4 member committee met to discuss the outcome of the evaluations undertaken.

It was discussed and agreed amongst the members that in short listing proposals received, wherever possible working along the lines mentioned in BACF priority spending areas to have a fair distribution of projects within the atoll and since this is the first cycle of grants to be awarded not to award 2 grants for one party or one island during this cycle. Also it was decided by the Committee that only to shortlist the best proposals received, upon comparison of the 4 Evaluators ranking based on the areas requested for funding from BACF.

It was also noted that there were 2 proposals from Manta Trust who were not eligible for funding from BACF but these 2 proposals were evaluated pending the outcome of a decision from BACF Board.

The table below indicates the list of proposals received evaluated and the comments by the Evaluators.

Conclusion

The Evaluation Committee agreed to recommend to BACF Board the proposals mentioned above to be shortlisted as beneficiaries of grants from BACF.

The Evaluation Committee also recommends BACF Board to make a decision on the proposal by Manta Trust, whether to shortlist or not as Manta Trust is not a direct beneficiary of BACF funding.

If Manta Trust cannot be given approval as a beneficiary of grants, BACF to select from the standby list a beneficiary preferably from the order in the standby list a proposal from an island which has not been shortlisted.

If the total sum requested from BACF exceed MVR 1,542,000.00 (One Million Five Hundred and Fourty Two Thousand Rufiya) to revise the detail budgets and workplans accordingly of the shortlisted proposals and BACF approve to accommodate the shortfall amount from BACF funds to entertain 9 proposals.
